Sir,

This is with reference to your letter dt. 21<sup>st</sup> November, 2007 regarding financing to Vasant Rao Naik Vimukta Jastis & Nomadic Tribes Development Corporation Ltd. (VJNT) by National Backward Classes Finance and Development Corporation (NBCFDC).

In this connection, it is to inform that the NBCFDC has released an amount of Rs.40.15 Crore so far to Vasant Rao Naik Vimukta Jastis & Nomadic Tribes Development Corporation Ltd. out of which Rs.1.42 Crore has been released during current financial year. The VJNT has also been requested to utilize the released funds within stipulated period and submit demand for next instalment as per guidelines of NBCFDC. I would also like to inform you that the funds were released to VJNT to the tune of Rs. 3.70 Crore, on 20.04.2007 with assurance by VJNT that outstanding dues are being repaid soon.

However, as on date, the outstanding amount has been accumulated to Rs.5.43 Crore due to non-repayment of loan by the Vasant Rao Naik Vimukta Jastis & Nomadic Tribes Development Corporation Ltd.

Therefore, it is requested that the State Government of Maharashtra and Vasant Rao Naik Vimukta Jastis & Nomadic Tribes Development Corporation Ltd. may be advised that the repayment of outstanding dues be made at the earliest, so that more funds can be released to VJNT for betterment of poorer section of the target group.
